- Proof of Household Income
- 2015 Social Security Award Letter/Pension Statement (if applicable)
- Three Most Recent Bank Statements; All pages, Checking and or Savings.
- Three Years of Tax Returns, 2012, 2013, 2014
- Current Homeowners Insurance – (Declaration Page Only)
- Current Property Tax Bill
- Hardship Letter
- Valid State Issued Photo ID
- Social Security Card

First Time Homebuyer/Down Payment Assistance Program

- Most Recent Pay Stubs (30 Days)
- Three Most Recent Bank Statements; All Pages, Checking and or Savings.
- Three Years of Federal Tax Returns with W-2', 2012, 2013, 2014
- Copy of Credit Report (Obtain a free credit report from <https://www.annualcreditreport.com>)
- Valid State Issued Photo ID
- Copy of Social Security Card
- Home Education Certification – (Required for most Lending and Down Payment Assistance Program)

- Copy of Lease Agreement
