Fair housing laws protect individuals from housing discrimination based on their protected class status, such as race, color, religion, national origin, sex, familial status, and disability. Fair Housing protects people from discrimination when engaging in housing-related activities lie including:

print & digital advertisements



viewing an apartment



seeking a home insurance policy



hiring a real estate agent



requesting accommodations



getting an appraisal



and much more.
